Mrs. LIEFER, Supervisor, American Airlines,
Midway Airport, Chicago, advised SA GARRETT P. FLEMING
on September 14, 1959, that JOHN PITTMAN held a reservation
for 4 on American Airlines Flight 606 due to depart Chicago
at 9:00 a.m., Central Daylight Time, September 15, 1959,
which flight was due to arrive at La Guardia Field, New
York, at 12:55 p.m., Eastern Daylight Time, September 15, 1959.

PITTMAN and family were observed by SA FLEMING
arriving at Midway Airport, Chicago, at 8:13 a.m., September
15, 1959, in a Rambler automobile, bearing 1959 Illinois
license 1147797. This automobile was driven by an unknown
white female, 5'1", 115 pounds, approximately 40 to 45
years of age, brown hair, and wearing glasses. PITTMAN and
family wandered about Midway Airport and about 8:50 a.m.,
boarded American Airlines Flight 606. This flight departed
Midway Airport for La Guardia Field, New York, at 9:00 a.m.
with PITTMAN and family aboard.

On July 22, 1959, TONI FREY, Gaylord Hotel, 5314-28 South Dorchester, Chicago, advised SA ROBERT A. VILLEMURE that he was the janitor of the above building located at 1367 East 53rd Street, Chicago. FREY stated that IRMGARD HEYMANN at that time resided in Apartment 206 at 1367 East 53rd Street.

MEMBER CG 6183-S, who has furnished reliable information in the past, advised on April 9, 1959, that at a meeting of the Social Workers Club of the Professional Division of the CP, of Illinois, held in Chicago on April 8, 1959, a membership discussion was held and it was decided that IRMGARD HEYMANN would continue as a member because she can occasionally attend meetings.
