For the information of the Bureau, the subject is a member and past chairman of the Dallas Chapter of the American GI Forum (see Bureau file 62-96541).

For the information of the Bureau, a confidential informant, on 10/4/54, advised that a chapter of the American GI Forum of Texas, Inc., was organized in Dallas, Texas, on September 29, 1954, and that the Communist Party (CP) was seeking to infiltrate this chapter at the time of its inception. This informant, on January 4, 1955, reported that the Dallas chapter of this organization was then controlled and dominated by the CP.

Another confidential informant, on December 17, 1956, reported that the Dallas chapter of the American GI

Forum of Texas, Inc., from the time of its organization in about September, 1954, until about October, 1955, was under the control and domination of CP members; that since about October, 1955, this chapter has only been infiltrated by a few CP members who attended occasional meetings. This informant had no information indicating CP members were being active in the affairs of that chapter.

WILLIAM J. LOWERY (former DL 2-S), DL 6-S and former DL 18-S, advised in July, 1955 that they do not believe the subject could ever be recruited into the CP or would ever be sympathetic to the CP. These informants have all advised that MOLINA opposed the CP faction within the GI Forum.

On 11/30/63, WILLIAM J. LOWERY (former DL 2-S) advised that he was contacted by JOE MOLINA who was considering a law suit against certain Dallas newspapers, radio stations and possibly the Dallas Police Department for alleging he was a communist.

Dallas will submit a security-type report on all activities of MOLINA and his association with Dallas CP members in the Dallas Chapter of the American GI Forum.
