FAR ew sakkun an ewe Washington State Child Protective Services (Washington State Angangen Tumunun Semerit) penueweni angang won ekkoock ekkei repwotun kaweten semiriit me tumwunungaw. Mwan FAR, CPS a penuwani/ angang won ekkei repwotun kaweten semiriit me tumwunungaw ne chosani.

FAR A ANGANG FENGEN ME EKKEWE FAMINI REPWE:

- Anisir fansoun ra nomw non osukosuk nge resapw kutta ewe saam/iin a wiseni awata ewe semiriit ika tumwunungaw ngeni.
- Anisir ar repwe tori ar kewe mwiicheich.

ME RUOMWON EKKEWE CHOON CHOSA ME FAR CASEWORKERS:

- Angang fengen me ekkewe famini fan itan tumwunun ekkewe semiriit.
- Kutta/sine met ekkewe famini ra mochen.
- Angang seni an ekkewe saam me iin me neeni nipwakeech me aninis mi wor ngenir.
- Kutta pekin aninis epwe ekinamweei fansoun osukosuk a kan aweiresi sipwe eteneki fichi met ekkewe semiriit ra mochen.

CHOSA:

- Apwungano pwe kaweten semiriit ika tumwunungaw mi fis.

Fansoun DCYF a angei ew repwot fan itan omw we famini, emon FAR caseworker epwene churuk an epwe pworaus ngonuk usun tumwunun noumw we semiriit.

Ewe caseworker oupwe nge angang fengen an epwe sine me finata ika kopwe mochen aninis an epwe ekisano an esapw fis kaweten semiriit me tumwunungaw non ekkun fansoun mwach. Noumw we caseworker epwe anisi omw we famini ne angang won ekkewe mettooch mi aweires.

Napengeni ekkei keis an FAR a kan kesipeno non 45 raan. Nge en me ewe FAR caseworker ouwa tongeni finata an omw ei keis epwe suk non 120 raan, ika epwe aniniseech ne sopwosopwonon ekkei aninis me anisi ewe angang mi eech ka pwopwueta.

- Ka tongeni finata kopwe eaea an CPS we pekin chosa.

- Anapano omw sine an epwe anisuk ren noumw kewe semiriit ren meinisin ier me kinikin.
- Angang won apechokunan nefinomw me neninomw we.
- Kutta ekkewe aninis mi wor non neniomw we me choon repwe anisuk won ekkei mochen/memeef ren pekin imweimw, angang, ika ren ekkewe ekkoock mettooch mi efisata omw weires me omw famini.
