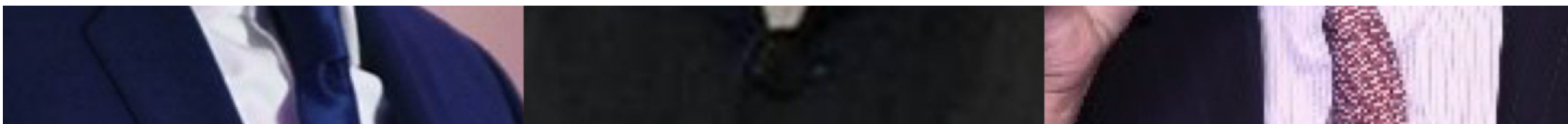

On March 19, 2018, Hunter Biden sent an email to Kevin Dong to ask the agency fee of Patrick Ho. The law firm was OWASCO, LLC opened by Hunter Biden. The email contained the following problems:

However, it is agreed that the cash withdrawal of 10,000 US dollars must be signed by both parties, which also shows that the CCP hopes to leave evidence in the exchange of money to control Hunter Biden.

3. Why Kevin Dong needed to pay Patrick Ho's agency fees? Because the leaders of Kevin Dong and Patrick Ho were the former chairman of CEFC China Energy, Ye Jianming, and the Biden family and Ye Jianming had very close relationships.

In summary, the Biden family represented by Hunter Biden has economic, commercial, and political contacts with CCP spies and CCP-controlled companies. What have all the Biden families sold to the CCP? I guess it is the power and future of the American people.
