On this day of why, 2018, Dominic Ruggiero appeared before me, an individual known personally to me the person that affixed his/her signature to this document below and being first duly sworn on this oath, hereby deposes and says:

I, Dominic Ruggiero, am over the age of 18, and am fully competent in all manner to make this affidavit. I have personal knowledge of the facts herein, and if called as a witness, could and would testify completely thereto.

I am a retired Medical Technologist with 22 years of experience. I am certified by the American Medical Technologists, ID# 72925.

In 2000 I became the target of workplace mobbing and organized stalking for the following reasons:

- 1 I witnessed, from February 1991 to 1998, the physical (assault) and mental ("workplace mobbing"; intense, organized harassment in the workplace) abuse of a coworker. This abuse was organized by, and some of the abuse was personally committed by one of the part owners of our place of employment. This part owner was also a Deputy with the Yavapai County Sheriff's Office at the time. This coworker committed suicide on 27 November 2000. That is, he was hounded to death.
- 2 I refused to enthusiastically participate in the abuse of my coworker.
- 2 I refused to forge documents and commit perjury for this employer.

A Brief Timeline of Events:

February 1991: I started my employment with this employer.

February 1991 to 1998: I witnessed the physical and mental abuse of a coworker. This abuse was organized by, and some of the abuse was personally committed by one of the part owners of our place of employment. This part owner was also a Deputy with the Yavapai County Sheriff's Office at the time.

Circa 1997: Involvement of the Prescott Arizona Police Department:

- My coworker vents to his family (mother and brother) about the abuse and threatens to kill our employer.

- The coworker's family reports the threat to the Prescott PD.
- The Prescott PD informs our employer of the threat and advises him to put on his Kevlar.
- The Prescott PD confiscates my coworker's firearms.

Circa 1997: My coworker stated to another part owner that, if the abuse didn't stop, he would go public with his story.

27 November 2000: My coworker commits suicide.

Circa 2000: I became the target of the abuse, both physical (assault and battery) and mental (workplace mobbing).

The workplace mobbing escalated to unambiguous death threats made by a fellow employee, who was also a Deputy with the Yavapai County Sheriff's Office and a longtime friend of the part owner organizing the harassment.

- He would point his finger in my face while shouting "Home Invasion!", "Home Invasion!".
- He would stand next to me and say, for all to hear, "Someone is going to wind up head first down a well!".

Mar 2002: I resigned in order to work in Phoenix, AZ for LabCorp (Laboratory Corporation of America) and later LSA (Laboratory Sciences of Arizona). The workplace mobbing continued at both of these places of employment.

Mar 2002: The organized stalking begins and continues to this day.

"Organized Stalking":

Definition: It is the ganging up by members of the community who follow an organizer and participate in the systematic harassment of an individual.

Goal: Is to provoke the victim to assault someone and get arrested, make the victim seem delusional/mentally ill ("gaslighting"), and to make the victim so depressed they become suicidal.

Methodology: This is done using well-orchestrated accusations, lies, rumors, bogus investigations, setups, framings, intimidation, overt or covert threats, vandalism, thefts, sabotage, humiliation, emotional terror and general harassment. The victim is stalked en masse by car and by foot in order alienate and isolate the victim.

Specific Tactics used on Me: Relentless harassment with lights and noise; hand signals; electronic monitoring inside the home and car; workplace mobbing; directed conversation and innuendo; erratic/ aggressive driving; and bizarre/rude/bullying behavior in the community.

This is an extreme criminal activity that is becoming more common and needs to be outlawed.

I declare under the laws of the United States and the State of Arizona that to the best of my knowledge and belief the information herein is true, correct, and complete.
