I am a neuroweapons Targeted Individual. I testified in my hearing as to the 21st Century threat. My true testimony and evidences presented legally compel Judge Jason Meche to work with me to make sure the military secures the field and that I am rescued. By placing me under interdiction Judge Meche is being used as a useful idiot in an information weapons assault that includes weaponizing medicine, law, and family to lay on more abuse. I am of sound mind and body and have clearly articulated the threat in the kangaroo hearing and over the last year I have suffered under interdiction. I can handle my own money and desire to get married, etc. My life has already been destroyed by an integrated neuroweapons takedown program for which I have provided ample evidence to counter the quack accusation that I'm a delusional schizophrenic considering these weapons are specifically designed to leave no trace and be misapprehended as mental illness. Judge Meche needs to do his due diligence, understand the 21st Century threat, and terminate my interdiction as I and others including Harvard/DoD neuroscientist and weapons designer Robert Duncan have demanded over the last year. Until Judge Meche terminates the interdiction and, based on the legally compelling best evidence, helps me call for the military to secure the field, he will remain in tortious error, derelict in his wartime duty, and in disgrace to the fallen who made the Ultimate Sacrifice for the freedom he has stolen from me. The UN is calling the crimes "cybertorture." I testified in court as to how I was targeted with Havana Syndrome and cybertorture in the psych ward after being misdiagnosed and committed there against my will. Will someone please appreciate this threat and act like it's a 21st Century emergency disaster situation, and stop pointing 20th Century Nazi information weapons at me for once and for all?
