EXPLANATORY NOTES

AGREEMENT

1. This NATO Standardization Agreement (STANAG) is promulgated by the Chairman MAS under the authority vested in him by the NATO Military Committee.

2. No departure may be made from the agreement without consultation with the MAS. Nations may propose alterations at any time should they consider that the original has become obsolete or requires improvement. Such proposals should be submitted to MAS where they are processed in the same manner as the original agreement.

3. Ratifying nations have agreed that national orders, manuals and instructions implementing this STANAG will include a reference to the STANAG number for purposes of identification.

DEFINITIONS

- 4. <u>Ratification</u> is 'The declaration by which a nation formally accepts the content of this Standardization Agreement'.
- 5. <u>Implementation</u> is 'The fulfilment by a nation's forces concerned of their obligations under this Standardization Agreement'.

RATIFICATION, IMPLEMENTATION AND RESERVATIONS

6. Page iii gives the details of the state of ratification and implementation of this agreement by the NATO nations. If no details are shown in the 'ratification ' and 'implementation' columns, it signifies that the nation has not yet notified MAS of its intentions: the appropriate Ministry of Defence is requested to do so as soon as possible.

7. Page iv (and page v, etc. if necessary) gives details of any reservations and proprietary rights that have been stated by nations.

8. If an amendment of substance or a new edition (other than an editorially amended edition) is promulgated, all previous ratification, implementation and reservation/restriction details are deleted from pages iii and iv and the amendment or new edition is processed in the same manner as the original agreement.

NATO STANDARDIZATION AGREEMENT (STANAG)

NATO MCM VEHICLES AND EQUIPMENT - AMP-3 (NAVY) VOLUME 1

<u>AIM</u>

1. The aim of this agreement is to register national acceptance of AMP-3 (NAVY) Volume I - NATO MCM Vehicles and Equipment - to be used by the Maritime Forces of the ratifying Nations.

AGREEMENT

2. Participating nations agree to use the publication AMP-3 (NAVY) Volume I as a manual for the information on NATO MCM Vehicles and Equipment.

3. Participating nations agree to provide appropriate date directly to the Custodian, who will collate this information and publish it as a change when necessary.

4. If a change of substance to the publication, i.e. something more than a change of information contained therein, is submitted to the Custodian, it will be forwarded to MAS, who will formally offer it to national authorities concerned for their agreement before being incorporated into AMP-3 (NAVY) Volume I.

IMPLEMENTATION

4. This STANAG is considered to be implemented when the necessary national orders/instructions bringing into effect AMP-3 (NAVY) Volume I have been issued to the authorities and units concerned.
