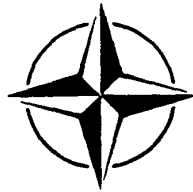

EXPLANATORY NOTES

AGREEMENT

1. This NATO Standardization Agreement (STANAG) is promulgated by the Chairman MAS under the authority vested in him by the NATO Military Committee.
2. No departure may be made from the agreement without consultation with the tasking authority. Nations may propose changes at any time to the tasking authority where they will be processed in the same manner as the original agreement.
3. Ratifying nations have agreed that national orders, manuals and instructions implementing this STANAG will include a reference to the STANAG number for purposes of identification.

DEFINITIONS

4. Ratification is "The declaration by which a nation formally accepts the content of this Standardization Agreement".
5. Implementation is "The fulfilment by a nation of its obligations under this Standardization Agreement".
6. Reservation is "The stated qualification by a nation which describes that part of this Standardization Agreement which it cannot implement or can implement only with limitations".

RATIFICATION, IMPLEMENTATION AND RESERVATIONS

7. Page iii gives the details of ratification and implementation of this agreement. If no details are shown, it signifies that the nation has not yet notified the tasking authority of its intentions. Page iv (and subsequent) gives details of reservations and proprietary rights that have been stated.

PRESSURE MEASUREMENT BY CRUSHER GAUGES

Related document : AEP-23 - Pressure measurement by crusher gauges - NATO approval tests for crusher gauges

AIM

1. The aim of this agreement is to ensure that pressure measurements made in one country in the manufacture or testing of guns, howitzers or ammunition for those weapons are acceptable to the other NATO countries so that compliance with specified pressure limits can be firmly established and safety in firing assured.

AGREEMENT

2. Participating nations agree to adopt the NATO approved crusher gauges mentioned in AEP-23 Part I for use in pressure measurement in connection with the acceptance testing of guns, howitzers and the ammunition for those weapons when measurements are to be passed to another nation. The crusher gauges shall have undergone the approval tests in accordance with the procedure laid down in AEP-23.

FUTURE DEVELOPMENT OF THE STANAG

3. This STANAG authorizes future changes to the list of approved crusher gauges in AEP-23 and to the content of the various chapters of the latter. That publication will accordingly be regularly revised and updated for the NATO Army Armaments Group by a subordinate group appointed for that purpose.

IMPLEMENTATION OF THE AGREEMENT

4. This STANAG shall be considered to be implemented when a nation has issued instructions that all pressure measurements of guns, howitzers and their ammunition shall be made in accordance with this agreement and AEP-23.
