AIM

1. The aim of this Agreement is to register national acceptance of AEP-4 defining methodology and criteria for the nuclear survivability of equipment and installations of the armed forces of NATO nations.

AGREEMENT

2. Participating nations agree that for military equipment and/or installations of all three Services (Army/Navy/Air) for which a capability to withstand the effects of nuclear weapons is required, the design criteria and methodology which will be used tro confer the required degree of survivability, will be that contained in AEP-4, published as follows:

ANNEX A (LAND) Edition 4 dated July 1990 (Volume 1(NC), Volume 2(NS)), "Nuclear Hardening Criteria for Armed Forces Material and Installations";

ANNEX B (NAVY) Edition 1 dated April 1987 (NC), "Nuclear Survivability Criteria for Naval Forces Material and Installations";

ANNEX C (AIR) Edition 1 dated October 1987 (NC), "Methodology for developing Nuclear Survivability Criteria for Aviation Material and Installations".

3. Changes to AEP-4 will be incorporated into the publication and will be accepted as part of it provided they have been formally offered by the appropriate bodies: AC/225(Panel VII)(LAND), AC/225(Panel VII/NSP) and AC/141(IEG/6)(NAVY), AC/224(Panel VII/ASP)(AIR) to national authorities concerned and have been agreed by them.

DEFINITIONS

4. The definition of "nuclear survivability" and other relevant terms, are given in paragraph 2 of AEP-4 Annex A.

IMPLEMENTATION OF THE AGREEMENT

5. This STANAG and AEP-4 are implemented when the AEP-4 ANNEXES A, B and C have been received by the authorities and units concerned.
