Observation Description :	To work effectively, legal advisors (LEGADs) require access to voluminous amounts of documents on many different aspects of law.
Discussion :	The Legal office has as part of their internal preparation, created an internal electronic library. This library not only includes documents specific to the operation, but also a large number of other relevant documents to include relevant NATO doctrine such as AD 80-70 and MC 362/1. The library was continually updated, both with NATO documents (as it became clear that they were needed), but also with more importantly papers produced and opinions given. Since the library was on the X:/ it was available to the entire HQ. Furthermore the HQ has taken steps to ensure that the library will be maintained for future use.
Conclusion :	This practice ensures both that all relevant documents are ready at hand. The FWD and RB HQs have an easy overview of advice given and hence save duplication of effort. It saves time, improves info flow as well as improving component coordination and joint thinking.
Recommendation :	Make this a mature observation and promote it as a Best Practice for NATO-wide promulgation.
