0.1. <u>PURPOSE</u>

The purpose of this document is to introduce to management and end users the content of NDSS Release 2.9.0.0.

0.2. SCOPE

This document is published by NSPA and addresses the NDSS user community. It describes the changes to the NDSS Software and provides NDSS end users and management with useful instructions for the use and implementation of the new functions and/or corrections.

Release 2.9.0.0 is distributed to all NDSS sites on 05th December 2017.

Release 2.9.0.0 contains a set of bug fixes and enhancements to NDSS software as identified in paragraph 3.
