



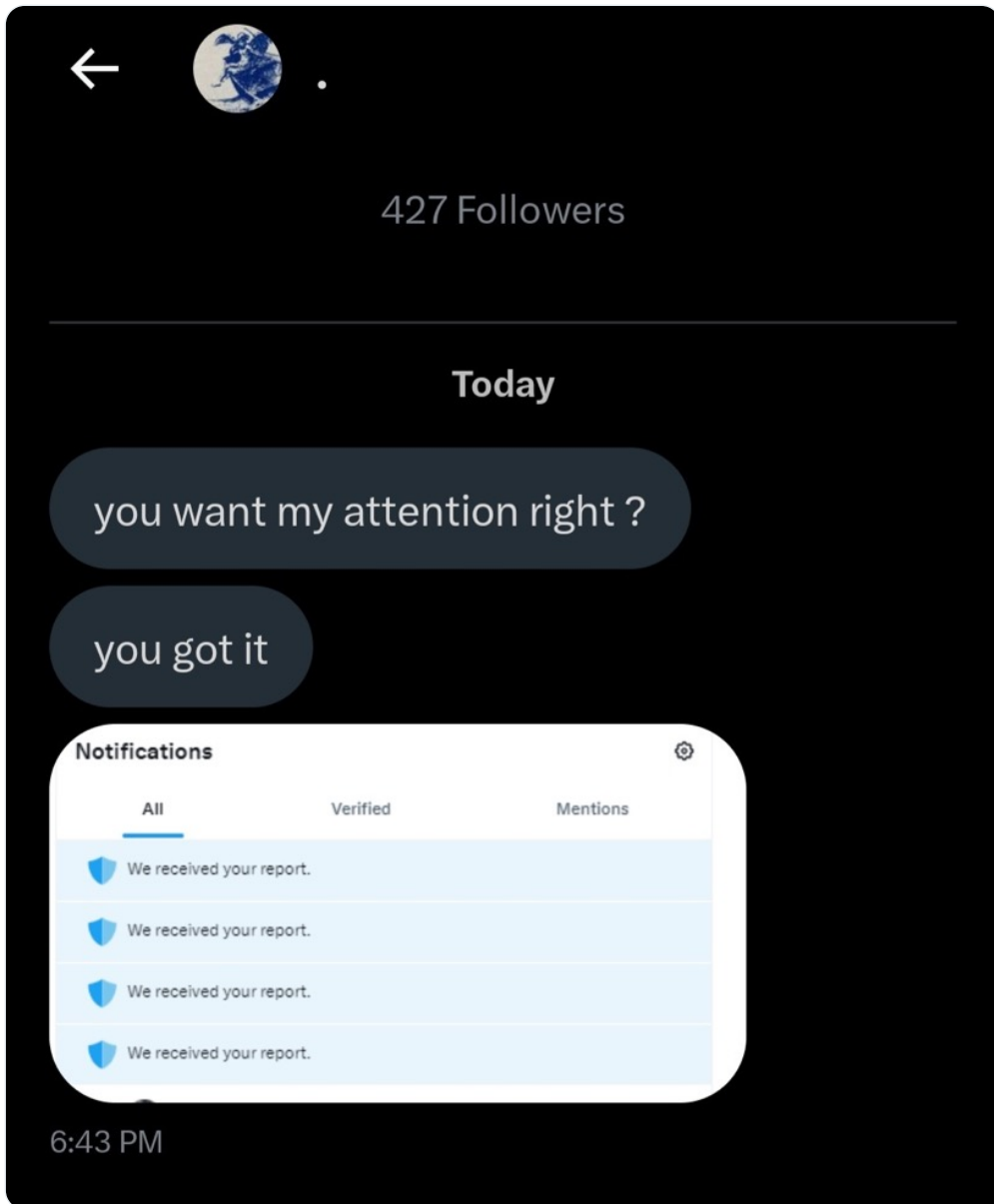

As you all know, I am all about accountability, so I am here today to hold myself accountable for weaponizing Community Notes against people or opinions I don't like.



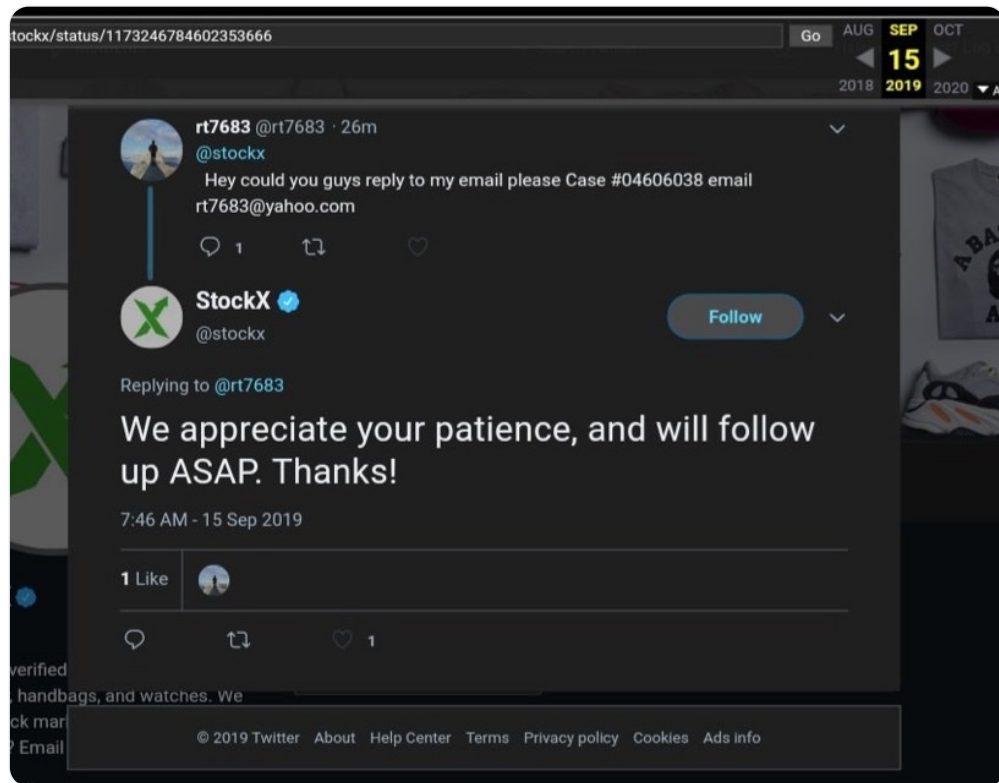

Compromised data: Email addresses, Names, Passwords, Physical addresses, Purchases, Usernames

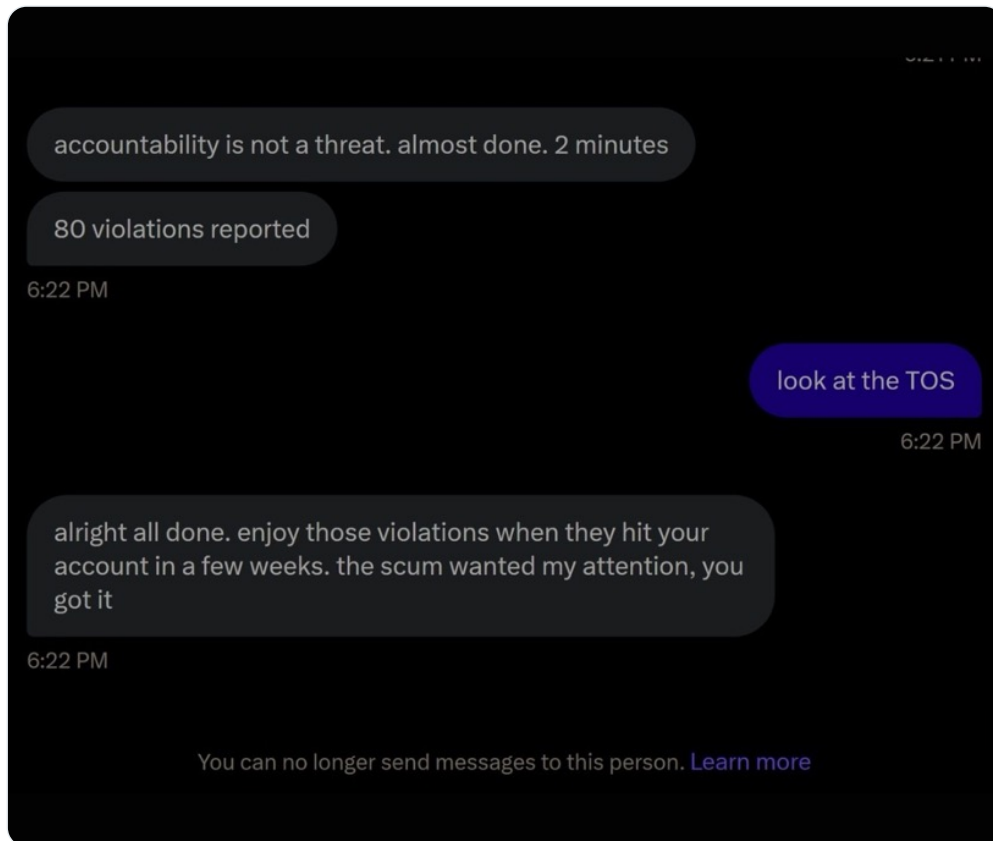

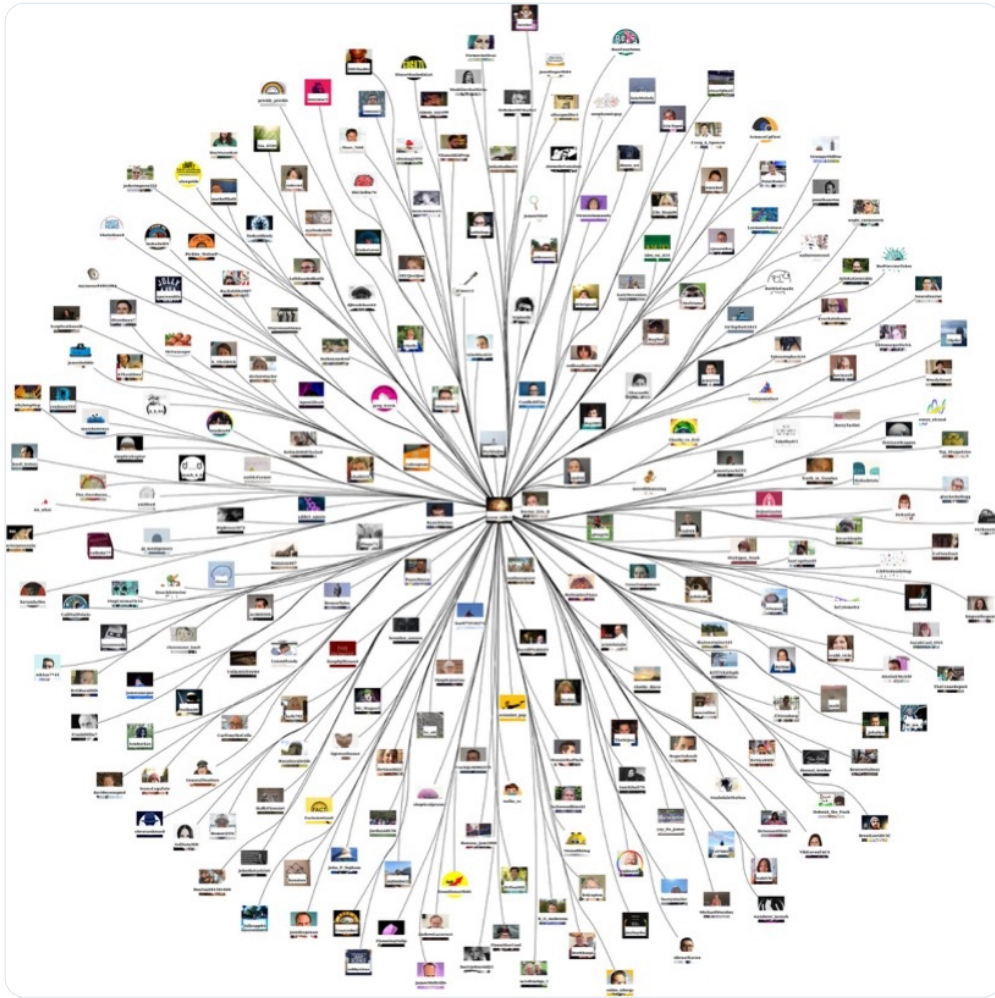
