(25)(x1) [REDACTED] MET WITH ICRC [REDACTED] DEC. 5 TO GO OVER THE REYES STATEMENT. ICRC IS UNABLE TO CONFIRM ANY OF HIS ASSERTIONS AND DOUBTS (25)(x1) RELIABILITY OF THE STATEMENT. [REDACTED] CITED THE FOLLOWING POINTS: (A) THE RIO NEGRO CAMP IS KNOWN TO HAVE BEEN USED AS A RELOCATION CAMP FOR CHILEAN NATIONALS, BOTH REFUGEES AND ILLEGAL MIGRANTS. ICRC HAS NO EVIDENCE THAT IT WAS EVER USED FOR POLITICAL DETAINEES. FOLLOWING THE INITIAL REPORTS OF THE REYES INFORMATION ICRC'S DELEGATE AGAIN MADE INQUIRIES, BUT NO NEW INFORMATION WAS DEVELOPED. (B) THERE IS NO RECORD THAT ICRC DELEGATES VISITED THE RIO NEGRO CAMP, AND CERTAINLY NOT BY PLANE IN THE MANNER DESCRIBED. IT IS NOT CLEAR FROM THE REYES STATEMENT WHETHER THE TWO "REPRESENTATIVES FROM ICRC" DESCRIBED THEMSELVES IN THAT MATTER OR WHETHER THEIR IDENTITY WAS INFERRED

(25)(x1) THREE FRENCH NUNS, [REDACTED] NOTED PUBLIC STATEMENTS MADE IN PARIS ONE MONTH AGO BY FRENCH NUNS WHO HAD BEEN DETAINED IN 1978 TO BE "EDUCATED" FOR PROPAGANDA WORK. THEY HAD BEEN CONFINED AT AN ARGENTINE NAVAL BASE. IN THIS CONNECTION HE ALSO CITED REPORT OF ARGENTINE COMMITTEE ON HUMAN RIGHTS IN MADRID (CADHU). B 6

(25)(x1) [REDACTED] REGRETTED THAT ICRC COULD NOT VERIFY REYES ACCOUNT. HE RECALLED A REPORT THAT THE FRENCH EMBASSY IN BUENOS AIRES HAD ALSO BEEN LOOKING INTO THE RIO NEGRO QUESTION (REF C) AND INQUIRED WHETHER WE HAD RECEIVED ANY INFORMATION FROM THAT SOURCE. PALMER B 6
