On June 15, 1965, So T-1, a Cuban exile leader in Puerto Rico who has furnished reliable information in the past, advised that he had heard on the local radio station that Dr. Orlando Bosch, leader of the MIRR and some of his associates had been arrested in Florida in possession of a number of aerial bombs for use in their raids against Cuba.

Source further stated that Bugenio lafitte, Puerto Rican representative of the MIRR, had called a secret meeting to be held on June 15, 1965, to talk over plans for some type of peaceful demonstration in Puerto Rica on June 16, 1965, to protest this arrest of a Cuban exile leader.
