

A copy of this letterhead will be disseminated locally to G-2, ONI and OSI in order that they may expedite any action they may desire to take locally.

NY 3465-S readily stated that she knew very little about military rockets and had previously seen very few; consequently she felt very unqualified to discuss these rockets in detail.

The letterhead memorandum has been classified "Confidential" because it contains information from a current active informant NY 3464 S Unauthorized disclosure of this dinformation could reasonably result in the identification of the source utilized. This would be prejudicial to the national Ethe source utilized. This woll is defense interest of the US.
