DISTRUBANCE

On March 12, 2023, at approximately 1115hrs, Officer Gensler was dispatched to the United Methodist Church in reference to a disturbance.

Upon arrival, Officers met with the complainant (non-LSU), who advised that an unknown female and male (non-LSU) had caused a verbal disturbance inside the church. Officers met with the subjects, who appeared to be emotionally disturbed, on the east side of the church exterior. EMS and BRFD were called to the scene to assist officers, and both subjects were transported to Our Lady of the Lake Hospital for further evaluation and treatment.

Prior to transport, when the female subject was being restrained in an EMS stretcher by officers and medical personnel, the female struck an EMS employee on the left side of her face. The female was later charged and issued misdemeanor summons# 013658 for violation of LRS 14:34.8 Battery of Emergency Services Personnel.
