Monthly Transportation Reimbursement

- Caregivers should use the Monthly Transportation Reimbursement form to request reimbursement for transportation-related expense. The form can be found at: https://www.dcyf.wa.gov/forms?field_number_value=07-090&title=
- Caregivers can request transportation reimbursement for activities including but not limited to Family Time, medical and mental health appointments, court hearings, and child specific meetings. - Completed forms can be turned into the child's caseworker. The forms must be legible and signed in order for the caseworker to approve the reimbursement request.
- Forms can be emailed, mailed, handed to, or texted (least preferred method) to the caseworker.

- Caregivers can contact a CaRES mentor for questions about the Monthly Transportation Reimbursement form.

Clothing Vouchers

- Please talk with your caseworker if you believe the young person in your care needs a clothing voucher.
- Clothing vouchers are available when a young person has an exceptional clothing needs not met through local community resources or the standard clothing allowance in the foster care monthly maintenance payment. Foster Care Licensing

Submitting Applications and Home Study Questions

- Please contact the Alliance Caregiver Retention, Education, and Support (CaRES) program (alliancecares@uw.edu) for support and answers to general questions about getting licensed and home studies.
- For more in-depth questions about your unique circumstances or home, please use the email address from page 15 that corresponds to your region.
- Please contact private child placing agencies (CPA) directly to request an application or ask questions about the agency's licensing process and requirements.

Renewal

- Please contact your Licensing Division Safety and Monitoring (SAM) Licensor for questions or to renew your foster care license.
- If you don't know who your SAM licensor is, please email your local Licensing Division (LD) team using the email addresses provided on page 15.
- Families licensed by a child placing agency should contact their CPA licensor for questions and guidance on how to renew their license.

Transferring Your License From a Child Placing Agency (CPA) to DCYF Licensing Division (LD) or Vice Versa

- Washington is home to many CPAs who certify foster homes. Families can also get directly licensed by DCYF's Licensing Division. It is up to caregivers to choose to work with one agency, a CPA, or DCYF Licensing Division.
- To transfer your license from a CPA to LD, caregivers need to turn an application in to their local Licensing Division Assessment office. LD tries to use as much information as possible from the family's previous agency.
- Please use the email address from page 15 to get in touch with your local LD Assessment office.
- To transfer your license to a CPA instead of working directly with LD, please contact the CPA directly.
