The National Biosurveillance Integration Center (NBIC) collaborates with and serves as a bridge between federal, state, local, tribal, and territorial (SLTT) partners to integrate information from thousands of sources related to biological threats to human, animal, plant, and environmental health to improve early warning and situational awareness. ### NBIC State, Local, Tribal, and Territorial Engagement Strategy Overview

The NBIC SLTT Engagement Strategy was developed, in part, for NBIC to articulate an integrated vision for supporting SLTT response agencies including health and agriculture departments. The NBIC SLTT Engagement Strategy outlines how NBIC will tailor operations and coordinate with federal interagency partners to provide NBIC overviews to SLTT officials. NBIC will demonstrate the value of increased bidirectional information flow, integration of data, and improved analytics to reduce the risk of biological threats of national concern.

Over the next several years, NBIC will focus on identifying and addressing specific SLTT capability needs, including areas where SLTT departments and national associations require more specific definition of requirements. NBIC will facilitate conversations about the broad exchange of data and information to better inform the products and resources it provides. Finally, NBIC will increase outreach efforts and provide NBIC overviews to SLTT health agencies and national associations on the utility of the products.

### NBIC SLTT Engagement Strategy Goals

**Goal 1:** Provide SLTT officials with timely, relevant, accurate, and actionable biosurveillance information and early warning analysis for biological events of national concern.

**Goal 2:** Provide educational opportunities and focused reviews to SLTT departments and national associations to reduce the risk of biological threats of national concern.

**Goal 3:** Demonstrate the value of increased bidirectional information flow, integration of data, improved analytics, and access to subject matter expertise for SLTT officials.

**Goal 4:** Capture new biosurveillance data needs and facilitate new NBIC projects.

### NBIC Vision and Priorities for SLTT Engagement



Establish, strengthen, and maintain relationships with SLTT officials to increase multidirectional flow of information and active SLTT participation in NBIC initiatives and biosurveillance capabilities development.



Identify and build a comprehensive understanding of SLTT biosurveillance tool and resource needs to inform planning and decision-making on countering national biothreats.



Provide opportunities to educate SLTT health departments and agencies about NBIC, including the products and services provided to establish a multidirectional flow of information.



Develop a shared understanding across SLTT departments and agencies on the current national biothreat environment.



Provide triage and redirection to appropriate subject matter experts. For this reason, NBIC is the integrator for all SLTT biosurveillance needs within CWMD.

## NBIC Impact and Products Available to SLTT Audience

### NBIC Impact:

- Produced 283 biosurveillance reports in FY22 that were disseminated to 656 SLTT partners to inform shared situational awareness of acute biological threats across SLTT agencies and support better decisions through rapid identification, characterization, localization, and tracking.
- Reached more than 600 recipients across 322 SLTT agencies and 11 common operating pictures and more than 1,500 federal recipients/lists representing 25 agencies and departments.

### NBIC Products: Monitoring List, Biosurveillance Event Report, Spot Report.

#### Monitoring List

**Purpose:** Summaries of acute biological events that impact human, animal, plant, and environmental health and may be of concern or interest to NBIC partners.

**Frequency:** Daily



#### Biosurveillance Event Report

**Purpose:** In-depth report of a major biosurveillance event, typically produced in reoccurring editions as events develop.

**Frequency:** As needed



#### Spot Report

**Purpose:** Short 1- to 2-page high-level summary report produced for isolated events or developments for rapid awareness.

**Frequency:** As needed
