

**CONTRACT FOR GRAPHIC DESIGNER**

THIS AGREEMENT is made this MONDAY day of 7th MAY 2012

**BETWEEN:** (i) **M/S AFRICA BROADCASTING (U) LIMITED** of P. O. Box 35933, Kampala, Uganda, (hereinafter called "**the Broadcaster**") which expression shall where the context requires or admits include its assignees and successors in title, of the one part;

**AND** (ii) **ABHISHEK KUNDU** of P. O. Box 700086, KOLKATA, INDIA (hereinafter called "**Graphic Designer**"), of the other part, both of them called "**the Parties.**"

**WHEREAS:**

1. The broadcaster operates a television station engaged in the business of broadcasting television programs in Uganda under the name of NTV;
2. The Graphics Designer is engaged in the business of Graphics for TV and Film under the name of Abhishek Kundu
3. To this end the Broadcaster and The Graphics Designer now wish to enter into this Agreement setting out the terms on which they shall conduct business.
4. Particulars of the Graphics Designer and other information relating to specific assignment of the subject of this contract are outlined in the schedule hereto.

**WHEREBY IT IS AGREED** as follows:

**1 ENGAGEMENT:**

The Broadcaster hereby engages the Graphics Designer (Abhishek Kundu) to undertake creative/ graphic design work on the broadcaster's channel - NTV Uganda. The tasks to be undertaken by Graphics Designer under this agreement shall include creating and/or design work on the following:

1. NTV STATION LOGO
2. NTV STATION IDENT
3. NTV STATION BUMPER
4. COMING UP TEMPLATE
5. PROGRAM LINE UP TEMPLATE
6. UP NEXT TEMPLATE
7. TODAY'S HIGHLIGHTS TEMPLATE
8. THIS WEEK ON NTV TEMPLATE
9. THIS WEEKEND ON NTV TEMPLATE
10. NEXT EPISODE TEMPLATE

3 Subject to the full and complete performance and observance by the Graphics Designer of all his obligations under this agreement and as full and final consideration for the services and for all rights granted to the Broadcaster pursuant to this agreement, the Broadcaster shall pay to the Graphics Designer the sums contained in clause 5 of this agreement.

4 **GRAPHICS DESIGNER OBLIGATIONS**

The Graphics Designer shall carry out the Services with due diligence, reasonable skill and care in accordance with commercially acceptable standards and ensure the delivery of high quality outputs. The Graphics Designer shall comply with the reasonable directives of the Broadcaster and use his best endeavors to promote the interests of the Broadcaster.

Here-in agreed that the Graphics Designer shall also endeavor (but is not obligated) to provide a week's training to the Broadcaster's Graphics team at an opportune time, upon or after delivery of the work. Note, travel and accommodation costs in this regard to be met by the broadcaster.

5 **RENUMERATION**

The Broadcaster will pay the agreed sum of US Dollars 5,000 to the Graphic Designer as full consideration for the services to be rendered by the latter. Said amount to be paid as follows:

40% upfront and 60% upon delivery of the finished works.

6 **APPLICABLE LAW**

This Agreement shall be governed by, and deemed construed in all respects in accordance with the laws of Uganda and the parties hereby submit to the exclusive jurisdiction of the Uganda courts.




